Note : 1) MITAS has offered conditional discount of USD 1,138,222.73 with a condition that discount shall be applicable if Package TW05 (*Package for Construction of 125 km of 500 kV S/C HVAC T/Line from Intermediate Point to Kyrgyzstan-Tajikistan border in Kyrgystan for CASA Project under IsDB funding*) is awarded to them and identical Towers/Same vendors used for TW06. Hence the aforesaid discount shall be applicable only in case TW05 is awarded to MITAS. Being a conditional discount, the same has been considered subsequently.

2) Exchange rates published as on 23.11.2017 by Central Bank of Kazakhstan has been used to convert all bid prices expressed in various currencies into US Dollar. As per Exchange Rate sheet: 1 USD = 330.22 Kazakh Tenge; 1 Euro = 388.07 Kazakh Tenge; 1 Kyrgyz SOM = 4.75 Kazakh Tenge; 1 Tajik SOM= 37.53 Kazakh Tenge.
